By registering on this portal and participating in the process for the award of petroleum prospecting licenses in the Nigeria 2025 Licensing Round, being administered through this portal ("**Portal**"), the Applicant or other user of this website ("**User**") hereby agrees to the terms and conditions ("**Terms and Conditions**") stated herein.

1 Licence to Use the Portal
